Guest Speakers – Houston Police Department

Officers Lucia Vieira - Central Patrol – Officer Vieira introduced herself and reviewed the monthly Positive Interaction with Police (PIP) Meeting which is open to citizens every 1st Tuesday of every month at the Police Union Building on State Street.

Sgt Tracey Hicks -Auto Theft - Officer Hicks introduced himself and his background. He reviewed the list of the most popular vehicles that are stolen for parts in order are the Chevy and GMC Pickups, Tahoes, Suburbans, Escalades, followed by the Ford F-150 pickup. The suggested new generation alarm systems, trackers and other anti-theft measures. He stated that on average 140 cars are broken into every day. Dodge Hellcats are another very popular vehicle to be stolen.

Another item that is commonly stolen are catalytic converters and they have a program for etching catalytic converters. The most targeted vehicles models are the Tundra, Tacoma, CRV, Prius and other vehicles. The other related crime is "jugging" where citizens are followed home from a bank and robbed. He also advised that you should use ATMs inside of buildings and be aware of those around you. In closing he also implored members not to leave guns in vehicles considering there were 4,410 reported stolen from vehicles in Houston last year.

Remember vehicles are stolen to commit other crimes, for parts or to resell the vehicle.

Lt. Larry Crowson fielded questions from the membership concerning other police matters.
