## **Environmental Affairs**

- 11<sup>th</sup> Street Park
  - There is a new project to complete the last 1/3 of the trails, however the cost is about \$37,000 and the project's scope may have to be downscaled to match exiting funds.
  - There is a possibility that the TMNA may do a joint fundraising 5K race, hopefully on an annual basis, to provide fundraising for the Park.
  - There is a need for a sponsor of the Wireless Wilderness Cell Phone Tour Cell.
    - A Motion was made to have TMCC provide \$5,000 to fund the cell phone tour for a period of three (3) years by Darlene Wayt.
    - Peter Davies seconded the motion which was approved by a show of hands with Lorraine Cherry abstaining from the vote.
  - There are plans for the COH to provide for a trail head at the area along Bryce adjacent to the Chemical Feed Station in the future. At this point the project is in the planning stage.
- Southwaste The owner still has not provided the requested information. The
  permit may be going to a Contested Case Hearing. The subject will be discussed
  at the upcoming General Membership Meeting.
- Jaycee Park –See attached report. May 13<sup>th</sup> General Meeting is scheduled as a Public Hearing for proposed Capital Improvements.
- Chemical Feed Station and Low Water Pressure No report from the City of Houston.

Environmental Affairs Report from Lorraine Cherry April 29, 2014

## West 11<sup>th</sup> Street Park

- 1. Trail project
  - a. Amendment of remainder of loop trail at West 11<sup>th</sup> Street Park with crushed granite and culverts.
  - b. Houston Parks Board original estimate: \$37,000. Includes all feeder trails and 2 curbed sections extending to the street (1 each on east and west sides.
  - c. Have asked for scaled down estimate; hoping for a final price tag of \$16,000 to \$18,000.
- 2. Visited with Brooke Boyett, CM Cohen's chief of staff. They are providing assistance and support for our efforts to find a sponsor for the cell phone tour.
- Contacted by Tommy Britt, representative of Old Timber Grove. They are planning a 5K run in April 2015 as a fundraiser for their neighborhood. In return for cosponsor ship by Friends of West 11<sup>th</sup> Street Park, they will direct some of the profits of the event to us for use in park projects.

### Bryce Street Park

- 1. Public Works will be beginning odor remediation project in January 2015, to be completed in June 2015.
- Houston Parks Board is planning to replant and refurbish the green space located on Bryce Street north of the chemical treatment plant to serve as a trailhead for the hike and bike trail. This will be part of the Bayou Greenways project. Long-term maintenance of this refurbished park will be undertaken by HPB, rather than the Parks Department.
- 3. The current design for the park calls for on-site, permeable surface parking, picnic tables, water fountain, and landscaping. We met with them at the site to discuss the plans, and made some further requests, including a dog waste bag station. We also pointed out some possible problems with their proposed design for new fencing to separate the chemical feed station from the park area.


## Southwaste Disposal






## **Page Views Statistics**






