Environmental Affairs Report for 10/27/2015 Board of Directors Meeting

- 1. West 11th Street Park:
 - a. The proposed trail maintenance and construction project for 2016 will cost approximately \$3,600. Friends of West 11th Street Park, with help from new board member Jennifer Vickers, is designing a social media marketing program to help underwrite this cost as well as other park expenses.
 - b. The *Wireless Wilderness* tour is continuing to attract visitors to the park. Plans are underway to introduce some new stops over the winter season and to launch a major new initiative to expand access to the visually impaired.
 - c. We are continuing to explore ways to mitigate the growing problem of off-leash dogs in both of our Timbergrove parks as well as in the neighborhood at large. This will become even more important with the start of the new security patrols in November. The SEAL team will include patrol dogs, and the neighborhood has been specifically asked to keep dogs on leash so that they don't interfere with these work animals on duty.

With additional notification posted at the park and on multiple FaceBook pages, there was a noticeable downturn in the number of offenders last month. Park users who see violations of the leash law are still being encouraged to file a complaint with the 311 system. We will be approaching Council Member Cohen's office for assistance in getting an increased presence from park rangers, and will also be investigating the use of additional signage, notification of other civic clubs, and assistance from The Leader.

- d. Motion: From money allocated for Donations in the 2015 budget, it is moved that the TMCC board donate \$400 to Friends of West 11th Street Park to offset the costs of trail maintenance and repair in the coming year.




