Following her presentation a number of residents asked questions about the particulars. The depositories handle carboard, yard waste, heavy waste, motor oils and other materials. The closet depository for Timbergrove is located on North Main at Crosstimbers. Hazardous wastes such a pint, aerosols and other items will need to be taken to their Westpark Depository.

March 10th Financial Report – Following review of the Financial Reports and the 2020 Budget, a motion was made to approve the Reports and Budget and was seconded. By a show of hands the Report and Budget were approved.

Committee Reports (Continued)

Deed Restrictions – No report or issues.

Design Review Committee – There is a new house under construction in Section 5 on Shelterwood. The builder has been contacted since there has been no submission to the committee which is required.

Environmental Affairs – Jennifer Vickers reported that the there are new board members including Jim Chambers. She asked that residents keep their dogs on a leash and pick up dog waste since these are the primary complaints by the Park's users. There has been no action on the renaming of the park by City Council.

There have been reports concerning homeless encampments in wooded areas around the Bryce Chemical Feed Station which have been reported to the Park Rangers (832) 395 -7100. There is no update of the on-going odor problems with the feed station.

The City of Houston has notified residents of Section 5 that the existing asphalt overlay of the underlying concrete roadway. Since the roadways are within the 100 year flood plain, there was a question whether this constituted fill in the flood plain which is prohibited. Previously when the City overlaid the streets in Section 6, they removed 2" of concrete so that there was no net fill.

The developer is continuing with the permit and development 150 house development directly behind Grace Church at 6325 Hurst, which is west of Section 5. SNC-14 members have continued to organize tours with elected officials to tour the area to see first hand the large amount of new development in the area.

Membership – Laura Branham reported that about 29% of the residents are member of TMCC. The most recent event was a membership drive at West 11th Street Park featuring a "dog walk" with a future event to send out thank you notes for recent donors. She will also be taking over as the Chair of the Block Captains committee.

Neighborhood Security – Jennifer Vickers addressed the crowd concerning the resurgence of the Citizens Patrol program with new volunteers going through background checks and training by the Houston Police Department. Volunteers are needed to drive an observe.

Timbergram – Alison reported that the recent edition has been printed and is in the process of being delivered.

Yard of the Month – Jennifer Wilson reminded residents that they have to be a dues paying member


