Officer's Reports

Secretary's Report - The Minutes for April 2020 Board Meeting were distributed, and no corrections were noted. A motion was made by Cynthia Schwendeman to approve these minutes which was seconded by Alison Reynolds. By a show of hands, the motion was approved.

Treasurer's Report – Jennifer Wilson reviewed her report indicated that the tax exempt status has been restored and that the CPA has filed the late tax returns. The latest available Financial Statements, dated May 26, 2020, are attached. After review by Board Members, a Motion to approve the treasurer's report was made by Jennifer Vickers and seconded by Ryan Derong. The motion was approved.

Committee Reports

Activities – Ice Cream social. There was discussion concerning the planned 4th of July Ice Cream Social and the thought of using a vendor, such as Kona Ice, to provide refreshments.

Beautification – Jennifer Wilson reported that the lawn maintenance is on a weekly schedule and there have been sprinkler repairs.

Deed Restriction Enforcement – Traci Riley reported that the main issue is 2311 Haverhill concerning a new build not meeting the Deed Restrictions. A further report is included in the attached report under Design Review Committee.

Design Review Committee – See the attached report by Dana Whitley.

Environmental – Section 5 Development is continuing with the construction of Palisades Park. There are issues concerning the importation of fill, increase in traffic and sheet flow into Section 5. There was further discussion of alternatives to alleviate traffic including extending Ella to the South. The Secretary has volunteered to draft a letter to the City of Houston requesting a traffic study for strategies to abate traffic impacts. Jennifer Vickers suggested future programs could feature developers and neighborhood input concerning the negative impact of these developments.

Jaycee Park – Traci reported that the work done previously done by Bullion Coatings has failed and that the splash pad is in desperate need of repair. She had additional ideas concerning raising funds to accomplish this task.

Membership – Report from Laura Branham is attached.

Neighborhood Security – There has been reports of gunshots emanating from the West 11th Street and Ella vicinity. It was suggested that when gunshots are heard, the location, time and date of the occurrence should be reported to the Neighborhood Security group.

Additional Reports Submitted for May 26, 2020 TMCC Board Meeting

Block Captain Report – By Laura Bradham

I emailed some of the Block Captains that have blocks that are regularly delinquent with Timbergram delivery to see if some of them would take on their own blocks as far as delivery. 4 Block Captains have answered the call, and their names have been submitted to Michele Kern to be added to the Timbergram delivery email.

I have emailed the Block Captains to let them know about the new Membership Contest. I will be emailing the specific numbers to each Block Captain as well so that each one will know where s/he stands in the contest next week.

I have emailed all of the folks that joined TMCC that live on Lillian Joliffe's block (6502-6614 Cindy Ln) to see if any of them would be interested in becoming a Block Captain. I found that one person had moved 2 years ago to Pineshade, and another might be moving out of the neighborhood due to employment complications from Covid-19, and another has a new baby. But, I didn't actually find a Block Captain, although they are all nice people. I did get a new name today when I got the newest names that have joined TMCC and I will email her tomorrow.

Membership Report – By Laura Bradham

As of May 26, 2020, we have a total of 451 official Members, 36% of the neighborhood. I have captured email addresses for approximately 90% of those that have joined this year, and that is a really handy tool to have when looking for a Block Captain. :)

I wrote a letter, put it in an addressed, stamped envelope, and took the envelope over to Jenn Wilson's so that when she had time to get a check written, she could include it and mail a refund to the 3 people from TMNA that accidentally joined TMCC this year. I also sent an email to the TMNA Membership Chair to let her know what had happened, not naming any names, of course. :) I was hoping that they might check and see if they had anyone from TMCC accidentally join TMNA. And, then today, when I got the latest Membership numbers, I found that we've had one more join from over there as well. I'll do the same thing next month for his refund. (None of these TMNA people are included in our official membership numbers.)

The new Membership Contest will be kicking off in June. The Blocks (long & short) with the highest percentage increase will receive wine for the NNO party in October. Any block that has 100% increase or better will automatically receive 2 bottles of sparkling wine for the

NNO party. We already have a block in that category: 6003-6031 Pineshade!

Deed Restrictions Enforcement - Report By Traci Riley

2311 Haverhill had been reported as a deed restriction violation. Followed up with number listed on permit to get plans over to DRC.

Had a call about a listing on Cindy asking if we had an HOA and if a business could be run out of the home. Informed person we were a civic club and that deed restrictions were enforced by the TMCC.

Spoke with Andrew Schaefer about ways that the development near Grace Church in section five might be violating deed restrictions.

I need to submit details and work with the website committee to make updates so deed restrictions and DRC process have a more prominent placement on the TMCC website.

Design Review Committee – By Dana Whitley

Attached is the revised document set for the proposed residence at 2311 Haverhill Drive in Section 14. Tracy and I had a cordial conversation with the designer, John Richardson, yesterday evening. He was unaware that there are deed restrictions, and was surprised that his client had neglected to inform him of that.

Much to my surprise, I found out that the set of documents that was sent to the DRC was an old set. The new design is almost 1000 sq. ft. smaller than the original. I have not had a chance to look at what the new set looks like, other than to see that it still has the second floor issue as before.

John is quite willing to revise the plans, with the approval of the owner of course. He was already going over what he could do in his mind.

Even though John is willing to revise the plans, I still have to provide a written decision per the requirements of the Section 14 Deed Restrictions. As much as I dislike having to give people bad news I am going to send a letter of denial this weekend to the owners. I think this will not come as a surprise given how much conversation has already occurred between the owners, contractor, Miles, and Traci.

Traci has informed me that the owners just want to get the project moving and wish to work within the deed restrictions. Hopefully this will not become a protracted issue.

Security Update – By Matt Kern

- As restaurants make their way back to some sense of normalcy we have started to revisit the idea of citizen's patrol training with HPD. A date has not yet been set. As the start of patrolling continues to get pushed further out we anticipate less annual spend which is mostly related to gas reimbursements for patrols.
- Per feedback from Rethink Security we have started increasing communication tips. Our first article was on reporting crime and the most recent was on wheel theft prevention. It was disappointing to see that this was one of the articles with the least amount of interest from an online clicks perspective.
- Pete Davies has graciously volunteered to assemble a list of signs related to neighborhood security throughout the neighborhood. Once assembled we will be looking to get the estimated costs for a sign renewal program.

Security Addendum – By Jennifer Vickers

Please find enclosed a report with analytics from the electronic version of the May Timbergram. You'll notice that the update from the president and cute feature on residents staying home (and doing lots of stuff in their driveways) received the most interest followed by the recycling update, security update, and Traces of Timbergrove feature. 



Daily Traffic Sources


