Membership - Laura Bradham reviewed her report as of September 9th with 504 members which was an increase over last year.

Neighborhood Security – Matt Kern reported Citizen Patrols have been on-going and they are proposing reimbursement, if requested, to cover minimal expenses, for the 15 hours of patrol time per week. Cynthia Schwendeman made a motion to support the proposal, for \$3.00 per hour reimbursement, which was seconded by Jennifer Vickers and approve.

There has been another report of lewd behavior in the parking lot of the Bryce Chemical Feed Station and may extend to West 11th Street Park. It was suggested employing SEAL Patrol to discourage these activities. Jennifer Vickers made a motion to approve a budget aof \$2,500 for the Security Committee to use SEAL Patrol to patrol the areas to discourage these activities, which was seconded by Ryan Derong and approved by members.

Nominating Committee – Traci Riley reported that the committee met and they have prepared a slate for the next year's election and will be published in the November Timbergram.

Overmeyer – There have been neighborhood complaints about the one way street and request it be reverted to a two (2) way street, discouraging cut through traffic. A second request will be drafted for this endeavor.
